## **Partner Visa (Subclass 309/100)**

### **Application Document Checklist for Applicants and Sponsors**

This document lists the information and supporting documents required for your Partner visa (subclass 309/100). It also lists additional documents that you may need to provide depending on your individual circumstances.

You must provide copies of the original documents. Certified copies or original documents may be requested during the processing of the visa application. Documents not in English must be translated by an accredited or professional translator. For clients in South Korea, English translation need to be notarised by a Notary Public.

You should ensure that you lodge a completed visa application. While you may be asked to provide more information in order to determine whether you meet the criteria for grant of the visa, a decision on the visa application may be made solely on the information provided at the time of application.

**Note:** The Visa Application Charge (VAC) will not be refunded if a decision is made to refuse to grant the visa because the applicant did not satisfy the criteria for grant of the visa or if the applicant requests for withdrawal of the visa application.
